# Terms and Conditions - Spring 2026 One-Day Wedding Offer

This offer applies to the following Spring 2026 dates:

Thurs 2<sup>nd</sup> April | Thurs 9<sup>th</sup> April | Thurs 16<sup>th</sup> April | Thurs 23<sup>rd</sup> April | Thurs 30<sup>th</sup> April

#### 1. Package Price & Guest Numbers

- 1.1 The package price is £20,000 based on a minimum of 100 guests.
- 1.2 Additional guests may be added at a rate of £135 per person.
- 1.3 Final guest numbers must be confirmed in writing no later than two (2) months before the wedding date. This confirmed number will be used for catering and invoicing purposes. Reductions in guest numbers will not be accepted after this point.

#### 2. Menu & Drinks

- 2.1 The package includes a curated 2-course wedding breakfast (starter & main or main & dessert) for 100 guests.
- 2.2 A single menu selection will apply to all guests, except for pre-approved dietary requirements.
- 2.3 Menu choices, including evening food selection, must be finalised no later than three (3) months before the wedding date.
- 2.4 The drinks package includes:

Italian "Fizz" (Durello) for the toast – Elderflower Fizz available as a non-alcoholic alternative.

Red & white table wine ("Le Sentier" selection) at ½ bottle per guest (350ml).

2.5 The venue reserves the right to substitute any food or drink items with a comparable alternative if necessary.

# 3. Venue Hire & Access

- 3.1 The package includes exclusive private hire of Thetford Farm Barn from 09:00 to 00:00 (Midnight) on the wedding day.
- 3.2 Access outside of these times is not permitted unless agreed in writing.
- 3.3 Couples may bring their own decorative items, provided they comply with venue safety guidelines (e.g., no open flames, only biodegradable confetti).
- 3.4 All personal items, decorations, and supplier equipment must be removed from the venue by 00:00 (Midnight) on the wedding day.

# 4. Entertainment

- 4.1 The package includes a hosted evening disco with lighting and amplified sound from 20:00 to 23:30.
- 4.2 Sound levels must not exceed 95 dB at any time. The venue reserves the right to adjust volume levels as necessary.
- 4.3 Any amendments to entertainment times must be requested in writing and are subject to availability.

#### 5. Planning Support

- 5.1 A dedicated wedding lead will be assigned to your booking to assist with your planning process and coordinate the smooth running of the wedding day.
- 6. Photography & Venue Promotion
- 6.1 The venue reserves the right to use photographs from your wedding day for promotional purposes unless a written request is received from the couple to opt out.

### 7. Liability

- 7.1 The client is responsible for any damage or loss caused by guests, suppliers, or third parties engaged by the client during the hire period.
- 7.2 All personal belongings and hired items are brought to the venue at the client's own risk.

#### 8. Booking & Payment

- 8.1 To secure the date, a signed booking contract and deposit are required.
- 8.2 Payment terms and cancellation policies will be detailed in the official booking agreement.
